## Brant Lake Camp Terms

1. The Directors reserve the right, at their discretion, to withdraw any camper whose influence or actions are deemed unsatisfactory to the Camp or who will not live within the rules and policies of the Camp. If this occurs, no reduction or return of fee or any part thereof, will be promised.
2. Camper's parents and/or guardian will be required to complete a camper profile form as well as provide the Camp with a medical certificate signed by camper's health care professional one week prior to the start date of Camp.
3. Camp is not responsible for camper's articles of clothing or personal belongings lost or damaged by fire, theft, laundry, etc. It is highly recommended that campers do not bring valuable items to camp such as expensive clothing, jewelry, cameras or electronics.
4. Due to fixed costs and expenditures based on definite enrollment, no refund or reduction can be guaranteed for arriving late or leaving early.
5. My child has permission to participate in all camp programs, camp trips and special outings planned and supervised by Brant Lake Camp.
6. Permission is hereby given for Brant Lake Camp, Inc. (Brant Lake Camp, Brant Lake Dance Camp, Brant Lake Sports Academy or any of its affiliates) to use in promoting camp and other ventures directly related to camp, digital, photographic, video and audio images and likenesses of the camper.
7. The parents and camper agree to abide by all policies, both written and verbal, set forth by the Camp.
