3. Camp is not responsible for camper's articles of clothing or personal belongings lost or damaged by fire, theft, laundry, etc. It is highly recommended that campers do not bring valuable items to camp such as expensive clothing, jewelry, cameras or electronics.
4. Due to fixed costs and expenditures based on definite enrollment, no refund or reduction can be guaranteed for arriving late or leaving early.
5. My child has permission to participate in all camp programs, camp trips and special outings planned and supervised by Brant Lake Camp.
6. Permission is hereby given for Brant Lake Camp, Inc. (Brant Lake Camp, Brant Lake Dance Camp, Brant Lake Sports Academy or any of its affiliates) to use in promoting camp and other ventures directly related to camp, digital, photographic, video and audio images and likenesses of the camper.
